Currently not supported	Transcribing the audio for Britannica's videos would be an immense manual process, for which a timeframe has not been identified. However, all videos are supplemental to the text-based encyclopedia articles, and not essential to the use of the product, given that the same information is contained in the articles.
(c) Web pages shall be designed so that all information conveyed with color is also available without color, for example from context or markup.	<i>Britannica Spanish Reference Center</i> features support this requirement.	Information in <i>Britannica Spanish Reference Center</i> is readable without use of color.
(d) Documents shall be organized so they are readable without requiring an associated style sheet.	<i>Britannica Spanish Reference Center</i> features support this requirement.	Information in <i>Britannica Spanish Reference Center</i> is readable without a style sheet.
(e) Redundant text links shall be provided for each active region of a server-side image map.	Not applicable	<i>Britannica Spanish Reference Center</i> does not utilize this server-side image maps.

Currently not supported	<i>Britannica Spanish Reference Center</i> rarely utilizes tables and the tables have a very simple structure, usually with a couple of simple columns. While we are working on this problem, most users will have little difficulty navigating our tables.

Currently not supported	Most Tables in <i>Britannica Spanish Reference Center</i> have very simple structures and do not use nested levels that need to be identified.
(i) Frames shall be titled with text that facilitates frame identification and navigation	Not applicable	<i>Britannica Spanish Reference Center</i> does not utilize frames.
(j) Pages shall be designed to avoid causing the screen to flicker with a frequency greater than 2 Hz and lower than 55 Hz.	<i>Britannica Spanish Reference Center</i> features support this requirement.	<i>Britannica Spanish Reference Center</i> is designed to not cause screen flicker.
(k) A text-only page, with equivalent information or functionality, shall be provided to make a web site comply with the provisions of this part, when compliance cannot be accomplished in any other way. The content of the text-only page shall be updated whenever the primary page changes.	Not applicable	All <i>Britannica Spanish Reference Center</i> pages can be rendered as simple text, and therefore there is no need to provide separate text-only pages.

(o) A method shall be provided that permits users to skip repetitive navigation links.	Not applicable	<i>Britannica Spanish Reference Center's</i> navigation links are simple and not repetitive.
(p) When a timed response is required, the user shall be alerted and given sufficient time to indicate more time is required.	Not applicable	<i>Britannica Spanish Reference Center</i> does not require user responses in a specific time.
